The first item was the election of officers for 2026. Kobliska nominated Becker for Chair. It was moved by Kobliska, seconded by Bosen, to approve the Chair for 2026. Motion carried unanimously. Kobliska then nominated Kurtenbach for Vice Chair. Motion moved by Kobliska, seconded by Becker. Motion carried unanimously.

Next, the introduction and approval of the agenda. It was moved by Kjergaard, seconded by Kobliska, to approve the agenda as presented. Motion carried unanimously.

Next, review and consider the minutes of the December 11, 2025, meeting. It was moved by Kobliska, seconded by Smock, to approve the minutes as presented. Motion carried unanimously

### Discussion Items

1. **Consider amendments to 2026-2029 TIP:** Moving the Waterloo La Porte Rd STBG funds from FY 2028 to FY 2026.

Fratzke provided the background and objective of the discussion regarding the La Porte Rd project. Jamie mentioned the possibility of moving the Gilbertsville 5th Street project. Fratzke provided an overview of the FY 2026 funding while noting that the Gilbertsville project and Black Hawk County Donald Street projects have already been let, and have a funding agreement in place, making it difficult to reprogram

those funds. Further discussion would be left to the individual jurisdictions. Jamie and Sweeney noted that the LaPorte Road Phase II engineering estimate is lower than programmed, which affects the local match and could help address the deficit. Sweeney stated that Phase II is scheduled for letting in March and Phase III in July and suggested rolling the adjustment into Phase III to remain fiscally constrained, with any STBG excess rolling forward. Fratzke explained that an administrative amendment could remove approximately \$130,000 from Phase III and revisit funding levels after bids to ensure fiscal constraint.

### **Project updates**

a. City and county project updates

Wicke reported for Cedar Falls that the Main Street project is completed, open, and punch list work is in progress. For Waterloo, Jamie provided updates on La Porte Rd: Phase I at 95% complete, Phase II bid in March, and Phase III in July. Brennan mentioned the joint project with Black County for the Donald overlay resurfacing, starting in the spring. Sweeney, IA -58 & Greenhill Rd intersection study is wrapping up utility coordination, and public information meetings in the spring, starting with the BUILD grant in coordination with IDOT, Cedar Falls, and calls for a support letter from jurisdictions and the MPO before 24<sup>th</sup> February. Fratzke mentioned that Evansdale got an award for the smoothness of Lafayette Road.

b. MET Transit - "How to Ride" Signage

Sturch noted that comments had been received from the City of Waterloo regarding the signage resolutions and that these would be addressed before submission to Council.

c. NEIA NEPA Study

Durbahn discussed the outcome of the December steering committee meeting, safety and capacity improvement alternatives for key corridors and intersections, highlighting significant safety concerns at Donald Street, Elk Run, and Cedar Wapsi Road, with IDOT studying the US 63/Cedar Wapsi intersection. Three improvement alternatives were outlined, and coordination with John Deere is ongoing. Upcoming steps include a January 21 steering committee meeting, public involvement, and an environmental review. Sweeney noted that the NEIA study meets requirements and could potentially support a BUILD grant application.
